PROFESSIONAL REQUIREMENTS

Professional requirements are satisfied by 21 credits of 2000-level or higher courses in engineering, science, mathematics or statistics including MGMT 5335, OPIM 3801, or up to 3 credits of ART 3670. The Proficiency Courses listed above count toward 12 of these 21 credits.

Restrictions on Professional Requirement Courses:

The remaining 9 credits may be satisfied by any course offered by the School of Engineering at the 2000 level or higher, or any science, mathematics or statistics course that were not used to meet another requirement in the curriculum. Following are specific restrictions to take note of:

- CE 3520 Civil Engineering Materials (F, S) or ENVE 3200 Environmental Engineering Laboratory (S) may be used <u>only if the other was taken for the laboratory requirement</u>
- "Science or mathematics" means any course with one of the following subject designations: BIOL, CHEM, EEB, GEOG, GSCI, LAND, MARN, MATH, MCB, NRE, PHYS, SOIL, TURF, STAT
